

## Analysis of Toys Recall Cases (July 2022)






In July 2022, there were totally 43 toys recalled cases from EU Rapex system. As for country of origin, one was from Czechia, one was from Hungary, two were from Poland, one was from Indonesia, five were unknown, the rest were all from mainland of China.

There were 4 recalled cases from US, one was from Vietnam, one was from Denmark, two were from mainland of China.

There were 2 recalled cases from Canada, two were from mainland of China.

There were 4 recalled cases from Australia, which the country of origin was unknown.



### CTI Suggestion

This month, the EU launched most of toy recall cases, the problem focus on small parts, there are 21 recall cases, which accounts for 49% of the total number of EU recall cases. It is worth noting that there are 12 recall cases caused by an excessive amount of phthalates, which accounts for 28% of the total number of EU recall cases. CTI reminds related toy manufacturers and exporters to focus on small parts from toy and restricted phthalates contents, timely adjust the product requirements in order to achieve the corresponding regulations.
